- Support positive participation with girls, parents/guardians, and/or other event participants.
- Represent the Council at all times in a positive and professional manner.
- Exhibit nondiscriminatory attitudes and behavior in all internal and external working relationships.
- Be guided in all actions by the Girl Scout Mission, Promise and Law.
- Complete the required event evaluation at the end of the program.
- Positively promote GSNEO's programs, services and goals to the community-at-large.

Position Commitments:

- Comply with GSUSA Policies, Standards and Guidelines, Volunteer Essentials, Safety Activity Checkpoints, GSNEO Bylaws, and GSNEO Volunteer Policies.

- Time: Varies; based on specific needs and volunteer interest.
- Recommended Training: Volunteering for Girl Scouts Series and Events (online)
 - o Additional training may be offered or required, depending on the event or program.
- Recommended Commitments
 - Membership & Administration Varies; depends on event and interest
 - Maintain a current GSUSA membership and complete the volunteer screening process to help ensure the safety
 of the girls and volunteers served through Girl Scouts. This is an administrative role and must be approved to
 handle funds.
 - Agree to opt-in to receive emails and text messages from GSNEO and GSUSA.

 respect and maintain the confidentiality of all privileged information related to Girl Scouts, its girl and adult members, volunteers,
