

Volunteer Position Description: Archery Instructor for Adults (Level II)

Summary: Archery Instructors are Level II Certified to teach and certify other adults. Archery Instructors are the foundation of GSNEO Archery programs, and archery program development. Obtaining this certification not only provides you with valuable knowledge and hands-on skills, but also boosts the marketing value of our program. Instructor Certifications are recognized by both USA Archery and the National Field Archery Association.

Position Supported By: Volunteer Leadership Development Coordinator and the Volunteer Support & Services Department. Additional support provided by a combination of staff and volunteers including the GSNEO O.W.L's and outdoor trainers, as well as GSNEO staff from Girl Experience and Customer Care teams.

Responsibilities:

- Teach at least two (2) Archery Facilitator courses annually.
- Facilitate at least two (2) days of Archery programs for girls annually.
- Conduct equipment checks before and after programs for safety, cleanliness, and good repair.
- Monitor and teach proper use of the Archery equipment.
- Report to Volunteer Leadership Development Coordinator or Property Manager any defective equipment for replacement.
- Evaluate program with other instructors and supervisor and make suggestions for improvements the following year.
- Assist in conducting annual equipment inventories.
- Support positive participation with girls, parents/guardians, and other volunteers.
- Communicate by phone and electronically with volunteers and staff prior to upcoming courses.
- Administer and submit program evaluations.
- Maintain and submit required documentation/reports for all programs and events.

- Membership & Administration
 - Maintain a current GSUSA membership and complete the volunteer screening process to help ensure the safety of the girls and volunteers served through Girl Scouts. This is an administrative role and must be approved to handle funds.
 - Agree to opt-in to receive emails and text messages from GSNEO and GSUSA.
 - Comply with GSUSA Policies, Standards and Guidelines, Volunteer Essentials, Safety Activity Checkpoints, GSNEO Bylaws, and GSNEO Volunteer Policies.
 - Tenure: 3 year (renewable); recertification is required every 3 years.
- **Time:** Instructors are required to teach at least two (2) Archery Facilitator courses, complete two (2) on-site Archery facilitator evaluations, and facilitate at least two (2) days of Archery programs for girls each year.
- Pre-Requisite: Completion of the Archery Level 1 Instructor Course
- *Required Training:* Girl Scouting Series and Event Training, Program Volunteer Training. Archery Instructor Certification course. Archery Instructor Course (16 hours)
- Highly Recommended: GSNEO leadership development courses (in-person and online).
