

Volunteer Position Description: Service Unit Support Volunteer

Summary: Service unit operations require the involvement of many volunteers and local troop participation. Service Unit Support Volunteers assist their service unit in many ways depending on local needs.

Position Supported By: This position reports to the Service Unit Director and is supported by the greater service team, the Customer Services team, and the Volunteer Support & Services Team.

Responsibilities:

- Help plan or coordinate service unit events and activities.
- Support other activities as determined by the service unit leadership.
- Communicate with service unit leadership, other volunteers, and troops as directed.
- Attend monthly service unit team meetings to stay current on local and council-wide information.

Position Commitments:

- Membership & Administration
 - Maintain a current GSUSA membership and complete the volunteer screening process to help ensure the safety of the girls and volunteers served through Girl Scouts.

Comfortable working with children

- Agree to opt-in to receive emails and text messages from GSNEO and GSUSA.
- Comply with GSUSA Policies, Standards and Guidelines, Volunteer Essentials, Safety Activity Checkpoints, GSNEO Bylaws, and GSNEO Volunteer Policies.
- **Tenure/Time:** Varies, based on the role/activity the volunteer is assisting with. Typically, 2 4 hours average per month based on activities outside of typical troops meeting. Please speak with your Service Unit Director for more information on the time commitment you can expect.
- *Required Training:* Intro to GSNEO on gsLearn.
- *Highly Recommended:* GSNEO leadership development courses (in-person and online).
