Release and Hold Harmless

In consideration of GSNEO allowing access of its property to me and other participants in the above described event, program or activity, I agree to the following:

I understand and recognize that there is always an inherent risk of bodily injury and harm associated with the activities described above. I further understand that no warranties or representations of any kind have been made by GSNEO, its employees, agents, officers, directors, successors or assigns regarding either: (1) the campgrounds' conditions or any activities which I may voluntarily choose to engage in while at the Camp; or, (2) the level of inherent risk of bodily injury and harm associated with such event/activity/program.

For this reason, I knowingly and willingly assume all risk of bodily injury and harm, death or loss to myself, arising from those risks inherent to such events/activities/program and other risks in exchange for being permitted to participate in the above events/activities/program.

Further, I, on behalf of myself and my heirs, executors, administrators, successors and assigns, and all other persons legally entitled to claim through me for any claim intended to be released hereunder, agree to fully, finally and forever release, discharge, hold harmless and indemnify GSNEO, its successors, assigns, officers, agents, directors, and representatives, the GSNEO, its employees, agents, officers, directors, representatives, successors or assigns, from any and all claims, obligations, demands, causes of action, debts, losses or liabilities (including attorney fees and costs), in law, equity, by statute, or otherwise, whether known or unknown, or later discovered, related to or arising out of any personal injury, illness, death or damage to personal property caused by any reason whatsoever (the "Claims"). I further covenant not to sue, or hereafter pursue or prosecute any of the Claims whatsoever, whether now known or hereafter discovered, against GSNEO, its employees, agents, officers, directors, representatives, successors or assigns.

In the event of injury, I give my permission to GSNEO to call, in the discretion of its employees, agents, or volunteers, the police, fire/rescue, or emergency medical services and to transport me to any hospital, clinic, or medical center. I further authorize emergency medical treatment for me and accept financial responsibility for such emergency care and treatment.

The above agreement shall be binding on my heirs, successors, assigns, administrators, executors, agents, employees, representatives, attorneys, and insurers. This Release and Hold Harmless Agreement is governed by the laws of the State of Ohio and is intended to be as broad and inclusive as is permitted by that law. If any provision is held invalid or unenforceable by a court of competent jurisdiction, the remaining provisions will continue to be fully effective.

I am aware that GSNEO has a policy that "the consumption and/or possession of alcohol, tobacco or controlled substances at any GSNEO activity or facility, is strictly prohibited", and I will adhere to the policy at all times while on GSNEO property.
