5. New Troop agrees to participate in the next Council sponsored Fall Product Sale or Cookie Sale.
6. The Troop Start-up loan is to be repaid with the Troop's profits from the next Council sponsored Fall Product Sale or Cookie Sale.
7. The \$50 new Troop Start-up loan must be re-paid in full by end of the next Council sponsored Fall Product Sale or Cookie Sale even if Troop's cookie profit does not cover the loan.
